Because vendor space is competitive for CKS Paddlefest, and we want the best experience for our participating vendors and the customer, please read the below vendor expectations before applying to a vendor spot.

VENDOR EXPECTATIONS:

- Staff member must be onsite/ present during vendor hours (see below)
- Enthusiastic about outdoor recreation and the Colorado Lifestyle
- Inclement weather is not unusual in Colorado. The event will proceed regardless of weather. Be prepared.
- You will be prepared to set up during setup hours, you will not break down before breakdown on Sunday.
- Vendors selling goods are required to either obtain a Buena Vista Business License, or to pay an event fee of \$15.00. Business Licences are valid through Dec. 31st, 2018, and can be downloaded at <https://www.buenavistaco.gov/DocumentCenter/View/181>. If you would prefer to pay the one time event fee, you may add an amount of \$15.00 to your security payment to CKS due on April 1st.
- Vendors must submit a log of sales to CKS, as well as payouts based on sales, no later than June 3rd.

VENDOR HOURS:

Setup: Friday 12:00PM-4:00PM

Breakdown: Sunday after 5:00PM

Required times to be present:

Friday 4:00 - 7:00 PM, Saturday 11:00 AM - 7:00 PM, Sunday 9:00 AM - 5:00 PM.
Any time the vendors choose to be present outside of the above required times is up to them. The more energy & participation vendors can bring to the event, the better.

PRICING:

The fee for one 10x10 Vendor booth is \$100. No application fees are necessary. In addition to the security fee, vendors selling goods at Paddlefest will be subject to additional payouts based on a sliding scale. The sliding scale is as follows:

- Vendors earning less than \$300 are not subject to a pay out.
- Vendors earning between \$300 and \$600 pay 10% of their sales.
- Vendors earning between \$601 and \$1000 pay up to 10% of sales up to \$600 (\$60), and 15% of sales beyond \$600. Ex. Deduct \$600 from total sales, multiply remaining amount by 15%, and add to \$60.
- There is a fee cap at \$1500 in earnings -- Maximum payout of \$195 plus the \$100
